

Global Fintech Fest (GFF) 2023 - Visitors and Delegates Terms & Conditions

These Terms & Conditions for visitors and delegates are applicable for every person registered as a regular visitor and/or delegate and/or speaker to attend the Global Fintech Fest 2023 ('GFF 2023') to be held at Jio Convention Centre, Mumbai, Maharashtra, India, from 5th to 7th September, 2023 (hereinafter referred to as "**GFF 2023/Event**"). GFF 2023 Registration
